“Construction of Link Road from Dhaka Trunk Road to Baizid Bostami Road including Loop Road at the outer periphery of AUW (Asian University for Women).” is approved by Govt. of Bangladesh and will be implemented by Chittagong Development Authority. Govt. has allocated fund for the above mentioned project and it intends to part of the proceeds of this fund to payments for consultancy services.

**2. Brief description of Service includes:**

- (i) Conducting digital survey to update the present contour & landscape.
- (ii) Review of existing drawing supplied by the consultant and updates it as where required.
- (iii) Design & Review of all service lines such internal and external water drainage line, gas lines etc.
- (iv) Supervision of Construction works.
- (iv) Vetting /Checking shop drawings, recommending variations, certifying IPC, advising employer on technical matters as and when necessary, etc in order to complete the Project as per the Contract and approved schedule of works.
- (v) Prepare technical specifications for all types of works/supplies/services.
- (vi) Preparation of detailed cost estimate with calculation sheets, preparation of Engineers Estimate, BOQ & Bid/Tender Documents separately as where required.
- (vii) Contract administration, Reporting & progress monitoring.
- (viii) Ensuring safety & security measures as per contract document.

**The Experience, Resources and Delivery Capacity required are:**

-The consultant shall deploy experienced and capable key personnel's for both design review and full time construction Supervision of the proposed road passing through number. of hills and natural channels with adequate number of supporting staff whose bio-data shall have to submit along with proposal.

-Appropriate experience and professional qualification of applicant's staff & resource to carry out the assignment, administrative strength & financial capability. The firm must have experience of successful completion of similar type of service in a single work order amounting not less than Tk. 100.00 Lacs within last 5 (five) years in Govt./Semi Govt./Autonomous Bodies. The firm should have to submit current income tax certificate, VAT registration certificate and other relevant documents.

- Consultant will be short listed and subsequently selected following QCBS method as per Public Procurement Procedure of Government of Bangladesh. It is expected that the Services will be commenced on or before 1<sup>st</sup> August-2014 and shall be completed at the time of completion of the submitting as built drawings.

-- Firms debarred by CDA need not apply.


Chittagong Development Authority now invites eligible Applicants firms to indicate their interest in providing the Services. Interested Consultants are invited to provide information indicating that they are
